I or We agree to pay said Auctioneer the sum of Ten Percent (10%) from the total amounts realized from said auction sale for his auctioning services.

A Twelve Percent (12%) Buyer's premium will be charged, paid by the buyer directly to the auctioneer.

All items without a reserve will be sold to the highest bidder.

I/We have read the foregoing Agreement and understand the contents thereof. I/We further represent that the statements herein made by me/us are true to the best of my/our knowledge; that the Agreement contains and sets out the entire agreement of the parties.

It is mutually agreed that this Agreement and **Exhibit A** attached shall be binding and obligatory upon the undersigned, and the separate heirs, administrators, executors, assigns and successors in interest of the undersigned.

I certify that I am the owner of the above listed goods, merchandise and/or property and have good title and have the right to sell and that they are free from all encumbrances. I agree to indemnify and hold harmless Southern N.H. Boat Auction, LLC and the Auctioneer against any claims of any nature referred to in this agreement.

1. **All boats or items sold in this sale are sold in "as is" condition.** All guarantees on consigned items are between buyer and owner and in no way shall Southern N.H. Boat Auction, LLC or auctioneer be responsible for correctness, warranties, or genuineness, or description of property. Condition of each boat/item is represented by the consignor, not the Auctioneer.
  
2. The transfer of title or ownership is between the buyer and the owner and in no event shall the auctioneer or Southern N.H. Boat Auction, LLC guarantee title. The owner is responsible for removing any license plates from his boat or trailer prior to Auction.

3. Insurance against all perils and loss must be provided by the consignor if such protection is desired. In no event does the auctioneer or Southern N.H. Boat Auction, LLC assume any liability for a consignor's boat, trailer or other items.
4. Boats consigned to the auction can be brought to the Auctioneer during the fourteen (14) day period (May 17-30) prior to the sale, and MUST arrive no later than 3 pm on May 30.
5. All boats or items must be removed from the premises no later than seven (7) days following the date of sale. In the event that the boat or item is not removed within this period of time, the Auctioneer will remove same and provide storage at the owner's expense for a fee of \$50 a day.
6. If the consigned boat or item(s) are sold by the consignor prior to the auction, the consignor agrees to pay the Auctioneer a sum equal to the agreed commission on the amount realized.
7. The Auctioneer/Southern N.H. Boat Auction, LLC reserves the right to reject any and all boats and items which, in their opinion, do not meet their standards of condition or age to be included in this sale.
8. The consignor will furnish good quality color photos of his boat or item which will be suitable for sale promotion.
9. This agreement shall in all respects be interpreted in accordance with the laws of the State of New Hampshire and subject to compliance with Article 2 of the Uniform Commercial Code.
